

**CHEFSTEPS IN YOUR KITCHEN: DINNER BY CHEFSTEPS AND JOULE  
SWEEPSTAKES OFFICIAL RULES**

**Important: Please read these rules for this Sweepstakes (the “Sweepstakes”).  
By participating in this Sweepstakes, you agree to be bound by these Official Rules and represent that you  
satisfy all of the eligibility requirements below.**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS  
SWEEPSTAKES.**

Sweepstakes void where prohibited by law. Subject to all state and federal laws.

1. **Eligibility:** The Sweepstakes is open only to individuals who satisfy all of the following requirements:

- Are a legal U.S. resident currently residing in the 50 United States or District of Columbia;
- Are at least 18 years old (or the age of majority in their jurisdiction, whichever is older) at the time of entry; and
- Pre-ordered the Joule product and received an email invitation from Sponsor to participate in this Sweepstakes before the Sweepstakes Period (defined below) begins.

2. **Sweepstakes Period:** The Sweepstakes starts at 12:00:01pm Pacific Time (PT) on April 21, 2016 and ends at 11:59:59pm PT on May 8, 2016 (the “*Sweepstakes Period*”). All customers who meet the eligibility requirements above are automatically entered in the Sweepstakes. Entrants must comply with these Official Rules to be eligible to win a prize. Sponsor’s or Sponsor’s designee’s computer is the official time-keeping device for the Sweepstakes.

3. **How to Enter:** By preordering Joule prior to 12:00:01pm PT on April 21, 2016 and receiving an email invitation from Sponsor, you are automatically entered into this Sweepstakes, assuming you meet the above eligibility criteria and other requirements in these Official Rules. Limit: Limit one entry per person. ADDITIONAL ENTRIES WILL BE DISQUALIFIED.

4. **Identity of Entrant:** Multiple participants are not permitted to share the same email address. In the event of a dispute about the identity of the entrant, entries made online will be declared made by the authorized account holder of the e-mail address used at time of entry. An “*authorized account holder*” means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business or educational institution) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning entry.
